Training is a requirement in some provinces in Canada already, NFPA has recently made changes to NFPA 10 - 2018 section 7.1.2.1 that states "persons performing maintenance and recharge of extinguishers shall be certified."

**The NFPA-10 Course is broken into three sections.**

## **NFPA-10:**

This portion of the course will lead the technicians through the chapters and Annexes of the NFPA-10 booklet. They will be asked industry related questions and guided through NFPA-10 to find the appropriate answers.

## **Extinguishers:**

During the extinguisher portion of the course, technicians will be shown proper inspection of an extinguisher. This will be shown through power point presentation. As well as, an Extinguisher "cut-away" to expose the inner working, which will assist in the understanding of how the recharging procedures operate.

At an added cost, additional training can be provided at our facility for those that require a more hands on approach such as new employees.

## **Testing:**

After Completion of the training portion of the course, technicians will be given a multiple choice test requiring 100% proficiency. You will require a copy of the NFPA 10 - 2022

If you do not have a copy, you can purchase one from us and have it shipped to you prior to the training date.
